



## **Medical Release, Liability Waiver, & Terms Agreed to As Part of SLU Registration**

### **MEDICAL RELEASE INFORMATION**

#### **Standard Medical Release (only applies to those that register as singles)**

In case of accident, illness, or other emergency, I request that SLU contact me. If SLU cannot reach a parent/guardian after conscientious effort, I give permission for staff to call paramedics. If a life-threatening emergency exists, I give permission for staff to call paramedics immediately and then contact me as soon as possible thereafter. I authorize and consent to any X-ray examination, anesthetic, medical, dental, or surgical treatment, and hospital care which, in the best judgment of a licensed physician or dentist, is deemed advisable. I agree to assume the financial responsibility for expenses incurred as a result of those services being provided. I also agree to be financially responsible for emergency medical transportation.

#### **Adult Medical Release**

The undersigned hereby authorizes treatment by a qualified and licensed medical doctor in the event of a medical emergency which, in the opinion of the attending physician, may endanger the undersigned's life, cause disfigurement, physical impairment, or undue discomfort if delayed, while the undersigned is participating in activities through Student Leadership University.

#### **Liability Waiver**

By submitting this form, you understand that there is always a possibility of injury or physical harm. Before you or your student can join SLU in one of these amazing experiences, you agree that Student Leadership University cannot let anyone participate in any activities without their releasing and holding harmless Student Leadership University. ## PAYMENT DEADLINES AND CANCELLATION AND TRANSFER FEES INFORMATION

### LIFT Tour Information

Regardless of reason, cancellations and transfers cost Student Leadership University. To offset these costs, the following fees will apply. In fairness to others, we cannot make exceptions.

#### **Cancellation Fees:**

- **30 days or more before departure:** 50% of the total cost of the program will be forfeited
- **Less than 30 days before departure:** 100% of the total cost of the program will be forfeited

**All monies are due at the time of registration.**

***All credit card payments will incur a 3% processing fee. This fee will be added to your account and automatically charged to your credit card within a week of initial payment.***

### 101 and 201 Information

Regardless of reason, cancellations and transfers cost Student Leadership University. To offset these costs, the following fees will apply. In fairness to others, we cannot make exceptions.

#### **Cancellation Fees:**

- **45 days or more before departure:** Deposit plus the cost of travel protection (if purchased) will be lost (Deposit may be transferred to new registration for current year and same program but cannot transfer to anyone currently registered)
- **30-44 days before departure:** 50% of the total cost of the program will be forfeited
- **Less than 30 days before departure:** 100% of the total cost of the program will be forfeited

**Transfer Fees:** (you replace current attendee with a new attendee for the same program)

- **15 days or more before departure:** No transfer fee
- **14 days and under before departure:** Transfers will incur a \$10 transfer fee

**Payment deadline:** A deposit of \$100 plus the cost of travel protection (if selected) is due at the time of registration. All remaining balance is due 45 days before conference. Any registration not paid in full by this day will incur a \$25 late fee.

***All credit card payments will incur a 3% processing fee. This fee will be added to your account and automatically charged to your credit card within a week of initial payment.***

### **301 Information**

Regardless of reason, cancellations and transfers cost Student Leadership University. To offset these costs, the following fees will apply. In fairness to others, we cannot make exceptions.

#### **Cancellation Fees:**

- **120 days or more before departure:** Deposit plus the cost of travel protection (if purchased) will be lost (Deposit may be transferred to new registration for current year and same program but cannot transfer to anyone currently registered)
- **91-119 days before departure:** 30% of the total cost of the program will be forfeited
- **61-90 days before departure:** 50% of the total cost of the program will be forfeited
- **Less than 61 days before departure:** 100% of the total cost of the program will be forfeited

**Transfer Fees:** (you replace current attendee with a new attendee for the same program)

- **120 days or more before departure:** No transfer fee
- **61 to 119 days before departure:** \$50 plus the cost of the airline ticket change (if airline allows change)
- **14 days to 60 days before departure:** \$100 plus cost of the airline ticket change (if airline allows change)
- **13 days and under before departure:** transfer may not be possible due to VISAs and Airline ticket regulations. If transfer is possible, all costs incurred by SLU will be transferred to attendee.

**Payment deadline:** A deposit of \$350 plus the cost of travel protection (if selected) is due at the time of registration. An additional payment of \$750 is due in February. **The final balance is due 90 days prior to departure. Any registration not paid in full by this day will incur a \$25 late fee.**

***All credit card payments will incur a 3% processing fee. This fee will be added to your account and automatically charged to your credit card within a week of initial payment.***

### **401 Information**

Regardless of reason, cancellations and transfers cost Student Leadership University. To offset these costs, the following fees will apply. In fairness to others, we cannot make exceptions.
